What is the overall <a href="#">deductible</a> ?	\$0 individual. Non- <a href="#">network</a> : \$10,200 individual	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a> .
Are there services covered before you meet your <a href="#">deductible</a> ?	Yes. <a href="#">Preventive care</a> , primary care, <a href="#">specialist</a> , and <a href="#">urgent care</a> visits, imaging, <a href="#">diagnostic tests</a> , generic, preferred brand, non preferred brand and <a href="#">specilty drugs</a> are covered before you meet your <a href="#">deductible</a> .
