What is the overall <u>deductible</u> ?	\$5,500 individual/\$11,000 family. Non- <u>network</u> : \$11,000 individual/\$22,000 family.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. Are there services covered before you meet your <u>deductible</u> ?	Yes. <u>Preventive care</u> and generic drugs are covered before you meet your <u>deductible</u> .
