What is the overall deductible ?	<u>Network providers</u> : \$635 individual/\$1,270 family. Non- <u>network providers</u> : \$10,200 individual/\$20,400 family.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this plan begins to pay. If you have other family members on the plan , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your deductible ?	Yes. <u>Preventive care services</u> , primary care, <u>specialist</u> and <u>urgent care</u> office visits, imaging, <u>diagnostic tests</u> and Rx drugs are covered before you meet your <u>deductible</u> .	This plan covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. What is the out-of-pocket limit for this plan ?	For <u>network providers</u> : \$875 individual/\$1,750 family. For non- <u>network providers</u> : \$12,900 individual/\$25,800 family.	The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services. If you have other family members in this plan , they have to meet their own <u>out-of-pocket limits</u> until the overall family <u>out-of-pocket limit</u> has been met.
What is not included in the out-of-pocket limit ?	<u>Premiums</u> , <u>balance-billing</u> charges, and health care this plan doesn't cover.	Even though you pay these expenses, they don't count toward the <u>out-of-pocket limit</u> .
Will you pay less if you use a network provider ?	Yes. See Find a Provider or call 1-877-617-0390 for a list of <u>network providers</u> .	This plan uses a <u>provider network</u> .
