<b>What is the overall <a href="#">deductible</a>?</b>	<a href="#">Network providers</a> : \$5,650 individual / \$11,300 family. Non- <a href="#">network providers</a> : \$11,300 individual/\$22,600 family.	Generally, you must pay all of the costs from providers up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a> .
<b>Are there services covered before you meet your <a href="#">deductible</a>?</b>	Yes. <a href="#">Preventive care services</a> and generic drugs are covered before you meet your <a href="#">deductible</a> .	This <a href="#">plan</a> covers some items and services even if you haven't yet met the <a href="#">deductible</a> amount. But a <a href="#">copayment</a> or <a href="#">coinsurance</a> may apply. <b>Are there other <a href="#">deductibles</a> for specific services?</b>	Yes, \$500 individual / \$1,000 family for <a href="#">prescription drug coverage</a> . <b>What is the <a href="#">out-of-pocket limit</a> for this <a href="#">plan</a>?</b>	For <a href="#">network providers</a> : \$7,650 individual/\$15,300 family. For non- <a href="#">network providers</a> : \$15,300 individual/\$30,600 family.	The <a href="#">out-of-pocket limit</a> is the most you could pay in a year for covered services.
