What is the overall <a href="#">deductible</a> ?	\$0	See the Common Medical Events chart below for your cost for services this <a href="#">plan</a> covers.
Are there services covered before you meet your <a href="#">deductible</a> ?	Yes, except for Preferred Brand (Tier 2), Non-Preferred Brand (Tier 3), and <a href="#">Specialty Drugs</a> (Tier 4). **Does this plan provide Minimum Essential Coverage? Yes.**
