What is the overall deductible?	For <u>preferred providers</u> \$4,000 per person / \$8,000 per family per calendar year.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u> ?	Yes. Preventive care, physician office visits, x-ray & lab tests, imaging, outpatient surgery, emergency room care, emergency medical transportation, urgent care, outpatient mental health & substance use disorder services, home health visits, outpatient rehabilitation & habilitation, durable medical equipment, hospice, and pediatric dental and vision care are covered before you meet your deductible.
