Important Questions	Answers	Why This Matters:
What is the overall deductible?	\$0 through the preferred provider network. \$5,000 per person / \$10,000 per family for <u>out-of-network providers</u> per calendar year.	Generally, you must pay all of the costs from providers up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u> ?	There is no <u>deductible</u> through the <u>preferred</u> provider network.	There is no <u>deductible</u> through the <u>preferred provider</u> network. You will however have to meet the out-of-network <u>deductible</u> before the <u>plan</u> pays for any out-of-network services (except for emergency services).

What is the <u>out-of-</u> <u>pocket limit</u> for this <u>plan</u> ?	For preferred providers \$4,500 per person / \$9,000 per family. For <u>out-of-network providers</u> \$25,000 per person / \$50,000 per family per calendar year.	The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services. What is not included in the <u>out-of-pocket limit</u> ?	Premiums, balance billing charges, drug discount, coupon or copay cards for prescription drugs, penalties for non-certification and healthcare this plan doesn't cover.
