What is the overall deductible?	\$4,000 per person / \$8,000 per family through the preferred provider network. \$8,000 per person / \$16,000 per family for <u>out-of-network providers</u> per calendar year.	Generally, you must pay all of the costs from providers up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u> ?	Yes. Preventive care, physician office visits, x-ray & lab tests, imaging, outpatient surgery, emergency room care, emergency medical transportation, urgent care, outpatient mental health & substance use disorder services, home health visits, outpatient rehabilitation & habilitation, durable medical equipment, hospice, and pediatric dental and vision care are covered before you meet your deductible.	This plan covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. Are there other deductibles for specific services?	Yes. Preferred pharmacy <u>deductible</u> \$300 per person / \$600 per family per calendar year. Pharmacy <u>deductible</u> applies to tiers 1-4. There are no other specific <u>deductibles</u> .	You must pay all of the costs for these services up to the specific <u>deductible</u> amount before this <u>plan</u> begins to pay for these services.
What is the <u>out-of-</u> pocket limit for this plan?	For <u>preferred providers</u> \$8,200 per person / \$16,400 per family. For <u>out-of-network providers</u> \$25,000 per person / \$50,000 per family per calendar year.	The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services. If you have other family members in this <u>plan</u> , they have to meet their own <u>out-of-pocket</u> limits until the overall family <u>out-of-pocket limit</u> has been met.
What is not included in the <u>out-of-pocket limit</u> ?	Premiums, balance billing charges, drug discount, coupon or copay cards for prescription drugs, penalties for non- certification and healthcare this plan doesn't cover.
