What is the overall deductible ?	\$0	See the Common Medical Events chart below for your cost for services this plan covers.
Are there services covered before you meet your deductible ?	Yes, except for Preferred Brand (Tier 2), Non-Preferred Brand (Tier 3), and Specialty drugs (Tier 4).	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost-sharing and before you meet your deductible . See a list of covered preventive services at https://www.healthcare.gov/coverage/preventive-care-benefits/ .
Are there other deductibles for specific services?	Yes, \$1,500 individual / \$3,000 family for prescription drug coverage . There are no other specific deductibles . What is the out-of-pocket limit for this plan ?	For network providers : \$6,750 individual / \$13,500 family. Not applicable for out-of-network providers .	The out-of-pocket limit is the most you could pay in a year for covered services. Do you need a referral to see a specialist ?	No.	You can see the specialist you choose without a referral .

Does this plan provide Minimum Essential Coverage? Yes.
