<p>What is the overall deductible?</p>	<p>\$0 at Indian Health Care Provider (IHCP) or with IHCP referral at non-IHCP; or network providers: \$5,450 Individual / \$10,900 Family. Out-of-network providers: \$15,000 Individual / \$30,000 Family.</p>	<p>Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan, each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible.</p>
<p>Are there services covered before you meet your deductible?</p>	<p>Yes. Preventive care services and urgent care office visits, children's eye exam and glasses are covered before you meet your deductible.</p>	<p>This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost-sharing and before you meet your deductible.
