What is the overall <a href="#">deductible</a> ?	<a href="#">Network providers</a> : \$7,400 Individual/\$14,800 Family. <a href="#">Non-network providers</a> : \$13,500 Individual/\$27,000 Family.	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a> .
