| Are there services covered before you meet your deductible ? | Yes. Preventive care services, children's eye exam and glasses are covered before you meet your deductible . | This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost sharing and before you meet your deductible .
