If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible . |
| Are there services covered before you meet your deductible ? | Yes, Preventive care services, primary care, specialist , urgent care office visits and generic brand drugs are covered before you meet your deductible . | This plan covers some items and services even if you haven't yet met the deductible amount.
