Are there services covered before you meet your <a href="#">deductible</a> ?	There is no <a href="#">deductible</a>	This <a href="#">plan</a> covers some items and services even if you haven't yet met the <a href="#">deductible</a> amount. **Does this plan provide Minimum Essential Coverage? Yes.**
